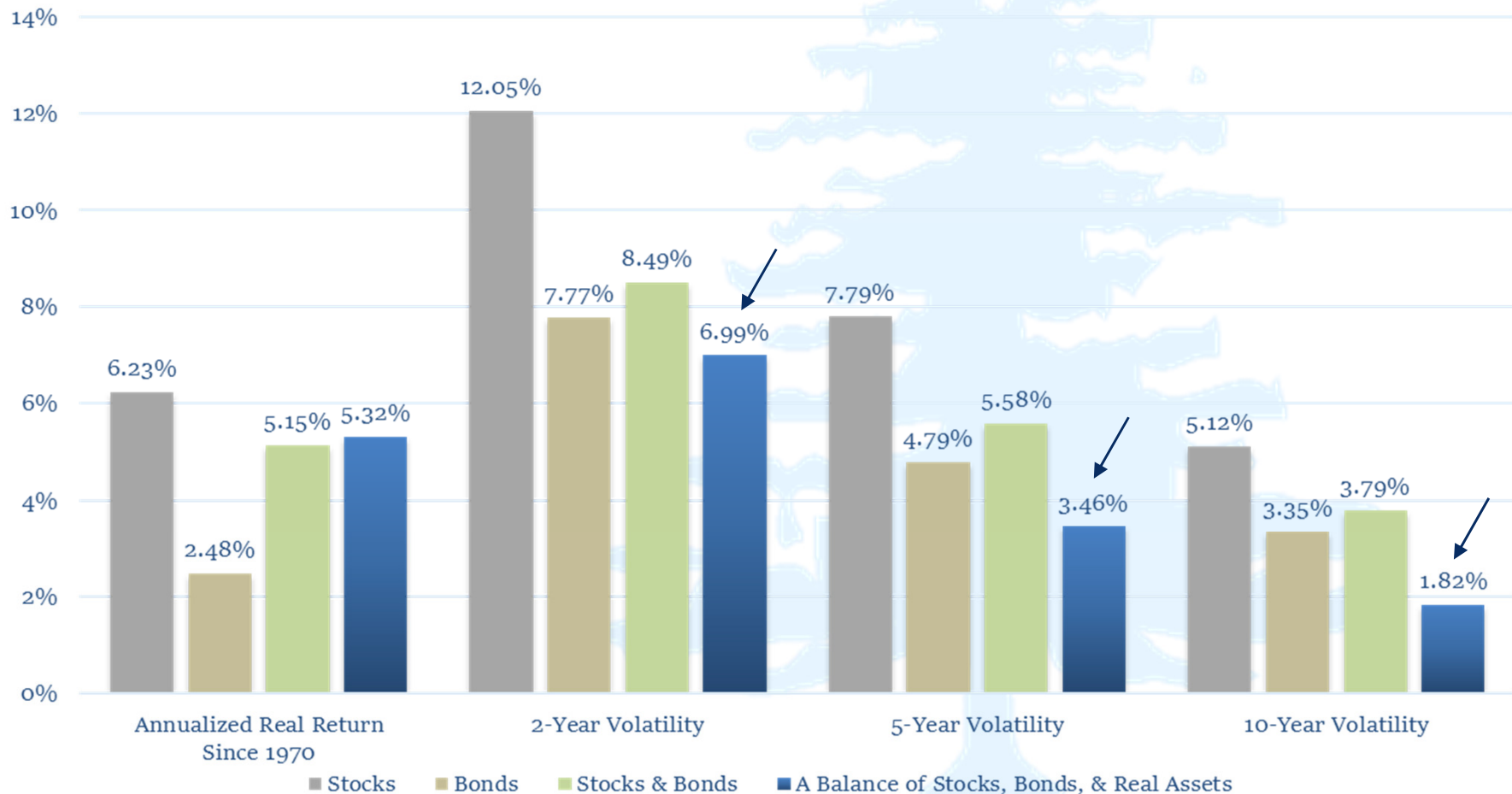

Inflation-Adjusted Market Returns & Volatility Since 1970

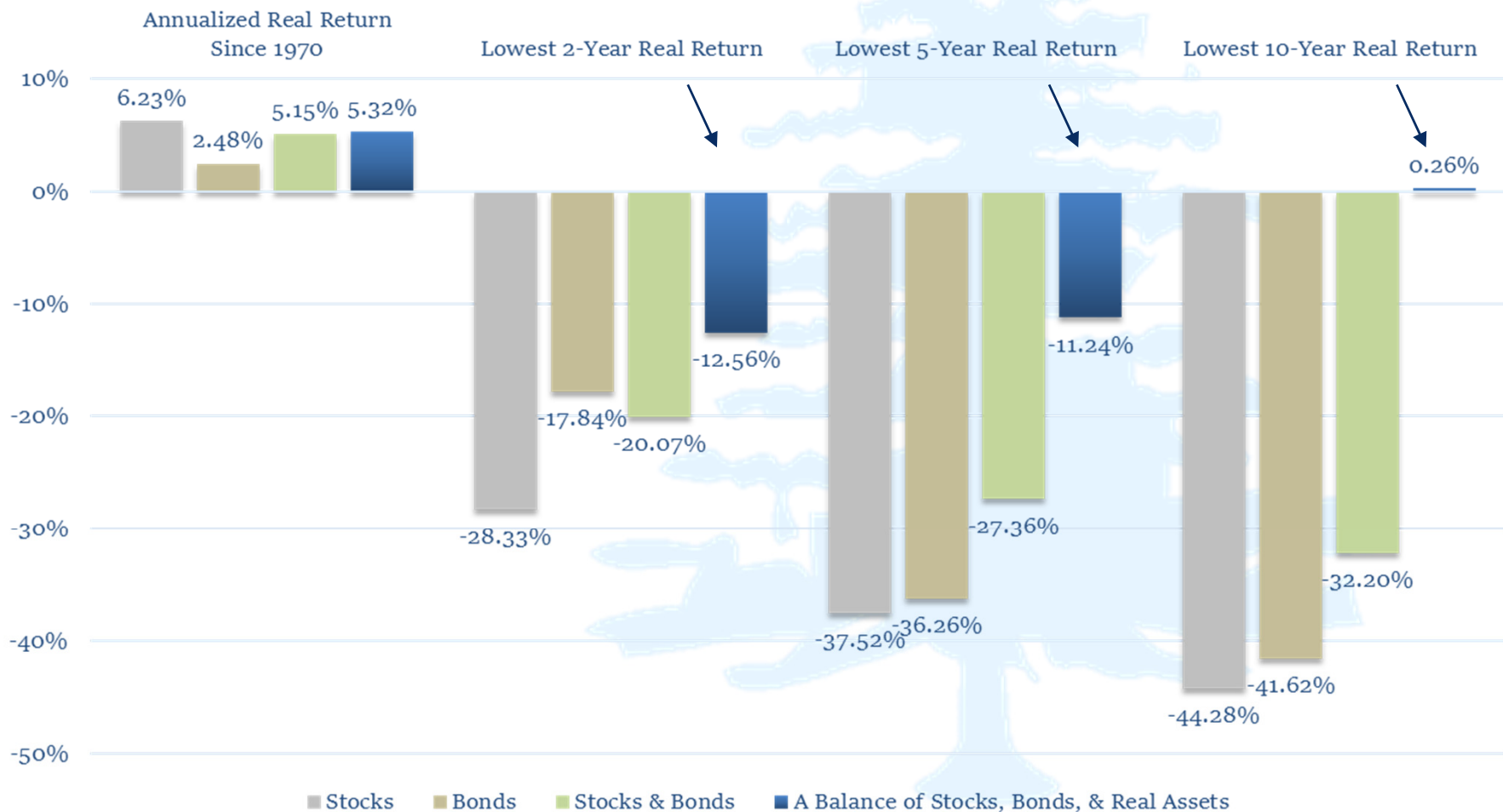


A Lower Risk of Prolonged Drawdowns
